

**HEALTH AND HUMAN SERVICES COMMISSION

AMENDMENT NO. 2**

The Health and Human Services Commission ("System Agency") and Gainwell Technologies LLC ("Contractor"), collectively referred to as the "Parties" to that certain Vendor Drug Program (VDP) Pharmacy Benefits Modernization Contract effective June 24, 2022, and denominated Contract No. HHS000534500001 ("Contract"), now desire to amend the Contract.

WHEREAS, the Parties desire to amend the Contract to allow for certain changes to be done via Minor Administrative Changes (MAC); and

WHEREAS, the Parties desire to amend attachments B, K and L of the Contract.

NOW, THEREFORE, the Parties amend and modify the Contract as follows:

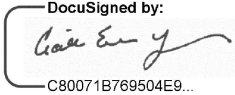

Future changes made to items, including but not limited to, retention schedules, Key Personnel, changes of address, contract representatives and any other minor contract changes, that do not increase or decrease the fee ceiling, modify the Special Conditions or Uniform Terms and Conditions, or do not affect or alter the rights of the parties will be done via a Minor Administrative Change.
2. Attachment B, Statement of Work is deleted in its entirety and replaced with Attachment B-1, Statement of Work, which is attached to this Amendment No. 2 and incorporated and made part of the Contract for all purposes.
3. Attachment K, Deliverables is deleted in its entirety and replaced with Attachment K-1, Deliverables, which is attached to this Amendment No. 2 and incorporated and made part of the Contract for all purposes.
4. Attachment L, Key Performance Measures and Liquidated Damages is deleted in its entirety and replaced with Attachment L-1, Key Performance Measures and Liquidated Damages, which is attached to this Amendment No. 2 and incorporated and made part of the Contract for all purposes.
5. This Amendment No. 2 shall be effective as of the date last signed below.
6. Except as amended and modified by this Amendment No. 2, all terms and conditions of the Contract, as previously amended, shall remain in full force and effect.
7. Any further revisions to the Contract shall be by written agreement of the Parties.

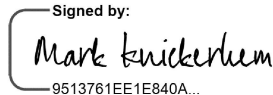
